Please read the following information:

Proceeds will benefit **Auth for Assembly**. New Jersey law prohibits entities operating in certain regulated industries (casinos, financial institutions, insurance companies, utilities) from contributing. Election Law allows contributions with a limit of \$2,600 per election from individuals and corporations, and \$7,200 per election from PACs.

A partnership or limited liability company may not contribute as an entity. However, a check from a partnership or limited liability company may be accepted as long as it is accompanied by a letter allocating the contribution to the individual partner (s) or member (s) and is signed by each contributing partner or member. The letter must include each contributing partner's home address. A partner's total contribution, through the partnership and personally, cannot exceed the \$2,600 per election limit.

Contributions are not deductible for income tax purposes.
